

#### **Finance**

For the full scope as outlined in the project plan, 20 participants are required. At the time of the meeting, 15 companies are participating. This is sufficient to start phase 1 of the project. As outlined in the open meeting on 8 Apr 2025 (also available on the STA-2 website) and presented in this meeting, phase 1 consists of the full scope except for the measurement techniques in WP2 (incl. electrical power measurement), the model tests in WP3 and the full-scale trials in WP4. In addition, changes in the Dutch government funding means we can only apply for 100 k $\in$  subsidy instead of the initially planned 25% = 305 k $\in$ . Note that approval of this subsidy is still pending. This increased the number of required participants for the full scope to 24.5.

The expectation is that we will attract additional participants. For them the early bird fee still applies, as it is extended to the next meeting (7-10 April 2026). This was unanimous decided during a vote during the meeting. In the unlikely event the number of participants remains 15, only phase 1 of the project will be executed.

Kasra Pakravan from Bureau Veritas asked if it was possible to move budget from WP5 (Procedures, implementation & dissemination) to WP4 (Validation trial campaigns). After an initial vote in favour of it, Jonas Wagner from HSVA and Prateek Gupta from Sintef Ocean asked if the decision can be postponed until the next meeting. This was unanimous decided in the third vote (that replaced the outcome of the second vote).
